LINEBERGER and E. M. PAUL, JR., their Heirs and Assigns, forever:

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, situate, lying and being on the West side of Mayflower Avenue, being Lot No. 62 in a subdivision known as Pecan Terrace, Plat of which is recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", page 9, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the West side of Mayflower Avenue, at the joint front corner of Lots Nos. 61 and 62, and running thence with the joint line of said lots, N. 72-27 W. 129.2 feet to an iron pin on the line of Lot No. 59; thence with the rear line of that lot and of Lot No. 58, N. 2-21 W. 74.5 feet to an iron pin, corner of Lot No. 63; thence with the line of that lot, S. 72-27 E. 157.7 feet to an iron pin on the West side of Mayflower Avenue; thence with said Avenue, S. 17-33 W. 70 feet to the beginning corner.
