All my undivided one-half interest in and to that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville, County, State of South Carolina, designated as Lot No. 42 on a plat of property of Eliza T. Looper, recorded in the R. M. C. Office for Greenville County in Plat Book H at pages 159 and 160, and having according thereto the following metes and bounds, to-wit:
