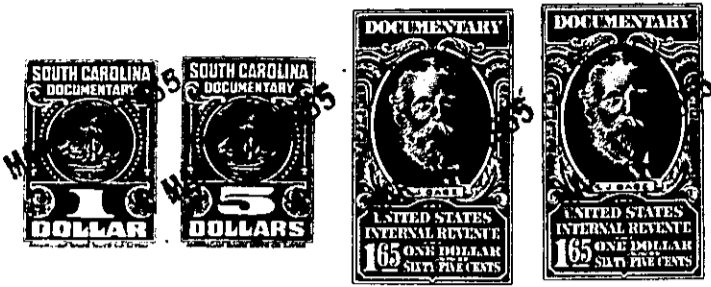

LOT NO. 37:

BEGINNING At an iron pin on the northeastern side of Courtney Circle at the joint front corner of Lots 36 and 37, and running thence along Courtney Circle N. 47-28 W. 69.9 feet to an iron pin, joint front corner of Lots 37 and 38; thence turning and running along the joint line of said lots N. 34-47 E. 184.3 feet to an iron pin, joint rear corner of Lots 37 and 38; thence S. 80-29 E. 87.0 feet to an iron pin in the rear line of said lot 37; thence S. 19-34 E. 63.0 feet to an iron pin, joint rear corner of Lots 36 and 37; thence turning and running along the joint line of said lots S. 49-47 E. 205.6 feet to an iron pin on Courtney Circle, the point of beginning.

LOT NO. 41:

BEGINNING At an iron pin on the northern side of Courtney Circle at the joint front corner of Lots 40 and 41 and running thence along Courtney Circle S. 77-40 W. 80.0 feet to an iron pin, joint front corner of Lots 41 and 42; thence turning and running along the joint line of said lots N. 12-20 W. 142.5 feet to an iron pin, joint rear corner of Lots 41 and 42; thence along the rear line of Lot 41 N. 82-45 E. 80.4 feet to an iron pin, joint rear corner of Lots 40 and 41; thence turning and running along the joint line of said lots S. 12-20 E. 135.2 feet to an iron pin on Courtney Circle, the point of beginning.

LOT NO. 45:

BEGINNING At an iron pin on the northern side of Courtney Circle at the joint front corner of Lots 44 and 45 and running thence along Courtney Circle S. 77-40 W. 101.4 feet to an iron pin at the intersection of Courtney Circle and Linda Lane; thence running along the curve of said intersection, the chord of which is N. 66-40 W. 57.0 feet to an iron pin on Linda Lane; thence along Linda Lane N. 31-00 W. 62.9 feet to an iron pin, joint corner of Lots 45 and 46; thence turning and running along the joint line of said lots N. 67-02 E. 170.9 feet to an iron pin, joint rear corner of Lots 46 and 45; thence turning and running along
