Township, Greenville

County State of South Carolina, containing Ten and four-tenths (10.4)
Acres, more or less, according to survey and plat by H.S. Brockman,
Registered Surveyor, in January, 1955, and having the following
courses and distances, to wit:

Beginning at a stake on the south side of South Tyger River, corner of W.A. Pollard Estate line where branch enters river, and running thence up said branch, S. 29.35 W. 172 feet to bend, S. 16.57 W. 297 feet to bend, and S. 56.19 W. 109 feet to stake on W.A. Pollard line; thence S. 19.45 E. 436 feet to iron pin on corner of Davis land; thence along the Davis line, S. 19.45 E. 209 feet to an iron pin; thence N. 10.00 W. 435 feet to a stake; thence N. 32.30 E. 460 feet to a stake; thence S. 70.00 E. 152 feet to a stake; thence N. 62.00 E. 275 feet to a stake; thence S. 82.30 E. 150 feet to a stake; thence S. 33.30 E. 172 feet to a stake; thence S. 83.15 E. 160 feet to a stake; thence N. 60.45 E. 212 feet to a stake; thence S. 86.30 E. 140 feet to a stake; thence S. 64.30 E. 108 feet to a stake; thence S. 42.30 E. 260 feet to an iron pin near branch, on line of Perry Smith land; thence along line of same, N. 21.30 W. 436 feet to South Tyger River; thence up said river as the line to the beginning corner.

It is understood and agreed that the described property, along with other parcels along South Tyger River, is to be used by the Commission of Public Works for a water shed or reservoir for the City of Greer. The seller herein, as long as he owns the adjoining tract from which the above described lot is conveyed, or the subsequent owners of the same, shall have the following rights and privileges, but subject to the following restrictions.

- 1. To pasture to the water line, or to cultivate crops to the high water mark in flood season, to withdraw water for irrigation purposes when the same is available, subject to State laws and regulations.
- 2. To fish in the waters of the reservoir, subject to the laws of the State and the rules of the S.C. Fish and Game Commission and the rules of the Commission of Public Works.
