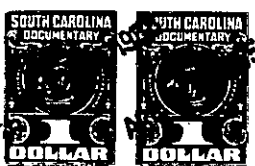

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Robert W. Edwards, his heirs and assigns forever;

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known and designated as Lot No. 84, Block A, of Orchard Acres, according to a plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BB, at page 103, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Watson Road, joint corner of Lots Nos. 83 and 84, and running thence along Watson Road, N. 9-19 W. 100 feet to an iron pin; thence along the joint line of Lots Nos. 84 and 85, N. 80-41 E. 200 feet to an iron pin; thence S. 9-19 E. 100 feet to an iron pin; thence along the joint line of Lots Nos. 83 and 84, S. 80-41 W. 200 feet to the beginning corner.

Property in this subdivision is subject to building restrictions set forth in a written instrument dated January 1, 1953, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Vol. 490, at page 111.
