Robert Hunt Smith and Annie Lou L. Smith to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Robert Hunt Smith and Annie Lou L. Smith and their heirs and assigns forever:

All that certain parcel or lot of land situated on the east side of Holly Circle, near the limits of the City of Greer and northward therefrom, in Chick Springs Township, Greenville County, State of South Carolina, being designated as Lot No. 8 of a subdivision known as Pinebrook, according to survey and plat by H.S. Brockman, Registered Surveyor, dated February 21, 1955, recorded in Plat Book FF, page 290, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning at an iron pin on the east side of Holly Circle, corner of Lots Nos. 7 and 8, and running thence along line of same, N. 67.05 E. 198 feet to a stake on bank of brook; thence down said brook as the line, N. 22.20 W. 100 feet to a stake, corner of alley; thence along south side of said alley, S. 67.05 W. 199 feet to iron pin on edge of Holly Circle; thence along said Circle, S. 22.55 E. 100 feet to the beginning corner.

This property is conveyed subject to the Restrictive Covenants as recorded in Deed Book 522, page 281, R.M.C. Office for said County, and is also subject to the right-of-way of sewer line and a 15-foot alley along same as shown on the plat.
