That WE, C. M. BALLEW and FAYE C. BALLEW,

in consideration of the sum of One and No/100 (\$1.00) ----- DOLLARS,
and assumption of the mortgage referred to below,
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RAY C. BALLEW, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on Irene Circle, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 23 on plat of Royal Heights, made by Dalton & Neves, Engineers, April, 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "W", at Page 25, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Irene Circle at joint corner of Lots 23 and 24 and running thence along the line of Lots 22 and 24, S. 63-53 E., 209.4 feet to an iron pin on the Northwest side of Irene Circle; thence with Irene Circle N. 4-39 W., 156 feet to an iron pin; thence with the curve of Irene Circle (the chord being N. 62-13 W., 45.4 feet) to an iron pin; thence with the Southeast side of Irene Circle S. 59-18 W., 119.4 feet to an iron pin; thence with the Southeast side of Irene Circle S. 53-55 W., 40.6 feet to the Beginning corner.

This is the same property conveyed to the grantors herein by deed of Franklin W. and Elva S. Powell, dated March 17, 1955, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 520, at Page 462.

The Grantee assumes and agrees to pay the balance due on that mortgage given by Franklin W. Powell and Elva S. Powell to C. Douglas Wilson & Co., in the original amount of \$6,750.00, on September 18, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Mortgage Book 509, at Page 359.

Grantee to pay 1955 taxes.
TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
