

BEGINNING at an iron pin on the western side of Rocky Knoll Drive, joint front corner of Lots Nos. 71 and 72 and running thence along the joint side line of said lots S. 64-34 W. 150 feet to an iron pin, joint rear corner of said lots; thence S. 25-26 E. 70 feet to an iron pin, joint rear corner of Lots Nos. 70 and 71; thence N. 64-34 E. 150 feet to an iron pin, joint front corner of said lots; thence along the western side of Rocky Knoll Drive N. 25-26 W. 70 feet to the beginning corner.
