Moseley, her heirs and assigns, forever:

All that lot of land situate on the Southeast side of Davidson Road, near the City of Greenville, in Paris Mountain Township, Greenville County, South Carolina, being shown as Lot 5, Block A, on plat of Hillandale Heights, made by T. M. Welborn, Surveyor, October 7, 1950, revised by J. C. Hill, February 15, 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "Y", Page 113, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Davidson Road at joint front corner of Lots 4 and 5, and running thence with the line of Lot 4, S. 73-33 E. 196.8 feet to an iron pin in the center of an 18 foot alley; thence with said alley N. 13-15 E. 18 feet to an iron pin; thence continuing with said alley N. 27-50 E. 82.3 feet to an iron pin; thence with the line of Lot 6, N. 74-06 W. 224.4 feet to an iron pin on the Southeast side of Davidson Road; thence with the Southeast side of Davidson Road S. 10-08 W. 100 feet to the beginning corner.

A strip of land 9 feet in width along the rear of this property lies within the boundaries of an 18 foot alley and this conveyance is made subject to the easement of said alley.
