ALL that parcel or tract of land situate on both sides of the new State road to Moonville, known as New State Road No. 23106, in Grove Township, Greenville County, South Carolina, being shown as a portion of that tract shown as property of J. A. Blackley, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "V" 135, and having according to said plat and a survey made by J. L. Hunter and T. J. Charles Estate, and running thence along the Northwest side of a County Road, S. 30-06 W., 1215 feet to an iron pin Northwest of said County Road; thence along line of other property of the Grantors, N. 86-55 W., 700 feet to an iron pin; thence continuing with other property of Grantors, N. 73-59 W., 99.6 feet to an iron pin near branch; thence N. 27-00 W., 287.1 feet to an iron pin; thence N. 10-03 W., 53.7 feet to an iron pin; thence N. 3-15 E., crossing the New State Road No. 23106, 484 feet to point in the center of old road; thence along the center of said old road, S. 89-29 E., 403.4 feet to an iron pin; thence continuing with the center of said old road, N. 79-00 E., 385 feet to a point in the center of New State Road No. 23106; thence along the center of said new state road, N. 74-00 E., 300 feet to an iron pin; thence continuing along the center of said new state road, N. 78-00 E., 200 feet to an iron pin; thence still along center of said highway, due East, 281 feet to the beginning corner, and containing according to said plat, 24.7 acres.
