to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Ralph H. Bloodworth, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in and near the City of Greenville, County of Greenville, State of South Carolina and being known and designated as Lot No. 30, Section H of Croftstone Acres according to a revised plat of a portion of Croftstone Acres prepared by Piedmont Engineering Service August 8, 1950 and recorded in the R. M. C. Office for Greenville County in Plat Book "Y", at page 91 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Broughton Drive, joint front corner of Lots Nos. 29 and 30 and running thence along said Broughton Drive, N. 73-22 E. 70 feet to an iron pin, joint front corner of Lots Nos. 30 and 31, said iron pin being 1258.8 feet from the intersection of Broughton Drive and Wedgewood Drive; thence along the joint side line of Lots Nos. 30 and 31, N. 10-37 W. 202.7 feet to an iron pin, joint rear corner of said lots; thence S. 72-49 W. 94.5 feet to an iron pin, joint rear corner of Lots Nos. 29 and 30; thence along the joint side line of Lots Nos. 29 and 30, S. 17-35 E. 200.4 feet to an iron pin the point of beginning.

The above is a portion of the property conveyed to the grantor by deed of T. C. Stone, et al dated January 10, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Book 516, page 497.

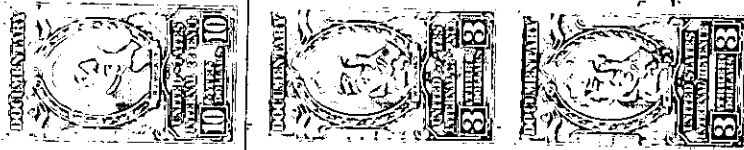
