Beginning on an old iron pin on the western side of the said Suber Road, joint corner of lots 66 and 67, and runs thence with the common line of these two lots, S. 68-52 W. 244.6 feet to an old iron pin; thence with the common line of lots 67 and 71, S. 24-10 E. 121 feet to a point on the northern bank of the Old Chick Springs Road (iron pin back on line at 3 feet); thence with the northern edge of the said Old Chick Springs Road, N. 52-41 E. 263.2 feet to an iron pin in the intersecting corner of the said two roads; thence with the western edge of the Suber Road, N. 37-39 W. 50 feet to the beginning iron pin.
