in consideration of the sum of Seven Hundred Fifty and No/100 - - - - - in the State aforesaid, DOLLARS,

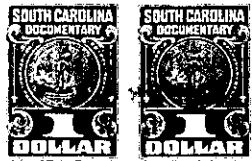
