ALL that lot of land with the buildings and improvements thereon, situate on the Northeast side of a surface treated road, now known as Turrentine Road about one mile North of Chick Springs, in Chick Springs Township, Greenville County, S. C., being shown as Lots 3 and 4, and a portion of Lot 2 on plat of property of Nellie Turrentine and Mrs. S.C. Thompson, made by H.S. Brockman, Surveyor, July 12, 1948, recorded in R.M.C.
