C. E. Robinson, Jr. and R. M. Gaffney, their heirs and assigns,

ALL that piece, parcel or lot of land situate, lying and being on the northeastern side of Lullwater Road in the City of Greenville, County of Greenville, South Carolina and being known and designated Lot No. 27 of a subdivision known as Northside Gardens as shown on plat thereof prepared by Dalton & Neves November, 1946 and recorded in the R. M. C. Office for Greenville County in Plat Book "S", page 17 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Lullwater Road, joint front corner of Lots Nos. 26 and 27 and running thence along said Road S. 37-13 E. 129.5 feet to an iron pin on the northeastern side of said Road, joint front corner of Lots Nos. 27 and 28; thence along the side line of said lots N. 80-45 E. 150 feet to an iron pin, joint rear corner of Lots Nos. 25 and 27; thence N. 9-15 W. 110 feet to an iron pin on the side line of Lot No. 25; thence along the joint line of Lots Nos. 26 and 27 S. 80-45 W. 218.6 feet to an iron pin, the point of beginning.

This lot is conveyed subject to the Restrictive and Protective Covenants applicable to the use of Northside Gardens recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 328, page 22, and Amendments thereto recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 462, page 337.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

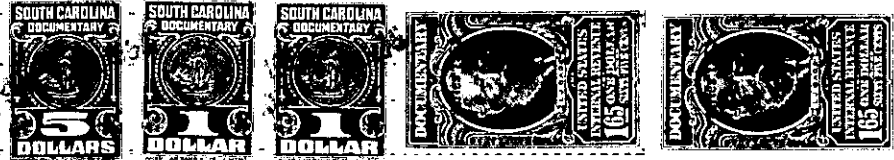
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
