

C. Jones & Associates, Englineers, recorded in the Office of the R.E.C. for Observille County in Plat Book W. Page 133, and being more particularly shown on plat of property of Robert L. Owens, dated May 30, 1955, propercd by 7. C. Jones, Engineer, and having according to said plat the following motes and bounds:

BEGINMING At an iron pin on the eastern side of Hillsile Lanc at the joint front corner of Lots 150 and 151, said iron pin being 235.1 feet south of the intersection of Hillside Lane and Pinc Creek Drive, and running thence along the joint line of said lots, 3. 78-24 E. 160 feet to an iron pin at joint rear corner of Lots 150, 151 and 152; thence turning and running along the joint line of Lots 151 and 152, S. 19-24 E. 135.5 feet to an iron pin on Piney Woods Lame at joint front corner of said lots; thence along Piney Woods Lanc, K. 72-30 W. 59.2 feet to an iron pin; thence N. 75-47 W. 58.9 feet to an iron pin; thence running along the curve at the intersection of Piney Woods Lane and Hillside Lane, the chord of which is N. 32-06 W. 34.7 feet to an iron pin on Hillside Lane; thence along Hillside Lanc, N. 11-36 E. 100 feet to an iron pin, the point of beginning.
