That We, J. Robert Edens and Kate P. Edens in the State aforesaid, in consideration of the sum of Five Thousand and No/100----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert L. Miller and Beauford Aiken Miller, their heirs and assigns

All that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as a portion of Lot No. 6 of Property of W. E. McClain as shown on plat recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book X, page 159, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of an unnamed road (now known as "U" Drive) and at the joint front corner of Lots Nos. 5 and 6 and running thence along the line of Lot No. 5, N. 74-50 E. 91 feet to a point at the corner of property being this date conveyed by the grantors to H. J. Payne and Frances R. Payne; thence a new line through Lot No. 6 and along line of property being this date conveyed to Payne in a northerly direction 84 feet to a point on the southern side of an unnamed road (also known as "U" Drive); thence along the southern side of said road, N. 87-10 W. 103 feet to an iron pin at the southeastern corner of the intersection of the two aforementioned unnamed roads (both now being known as "U" Drive); thence along the eastern side of the unnamed road first above mentioned S. 13-40 E. 114 feet to the beginning corner.
