

Richard E. Rupp, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot no.114 of College Heights as shown on plat thereof recorded in the R.M.C.Office for Greenville County in plat book P at page 75, and having according to a more recent survey made by R.W.Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Auburn Circle, the joint corner of lots nos. 114 & 115, and running thence with the joint line of said lots, S 13-43 E,149 feet to an iron pin; thence S 76-13 W,75 feet to an iron pin corner of 1ct no.113; thence with the line of said lot N 13-43 W,149.1 feet to an iron pin on the south side of Auburn Circle; thence with the south side of said street, N 76-17 E, 75 feet to the point of beginning.

Being the same lot of land conveyed to the grantor by deed recorded in deed book 451 at page 365.

This lot is conveyed subject to the restrictive covenants applicable to College

The grantee assumes and agrees to pay the balance due on that certain note and mortgage due C. Douglas Wilson & Co. recorded in Mortgage Book 523 at page 55, which balance is \$5,976.61; the grantee herein agrees to make the payment on said mortgage which is due July 1, 1955.
