J. P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 1 of the Property of W. T. Patrick and W. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book II at Page 93, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Lowndes Hill Road at the joint front corner of Lots 1 and 2 and running thence S 13-30 E 166.6 feet to a point at the joint rear corner of Lots 1 and 2; thence S 76-30 W 80 feet to a point on the Eastern side of Oakland Drive at the rear corner of Lot 1; thence with the Eastern side of Oakland Drive N 13-30 W 130 feet to a point; thence following the curvature of the Southeastern intersection of Oakland Drive with Lowndes Hill Road (the chord of which is N 25-22 E 31.1 feet) to a point; thence with the Southern side of Lowndes Hill Road N 64-34 E 61.8 feet to the point of beginning.
