in consideration of the sum of FOUR HUNDRED AND NO/100----- DOLLARS,

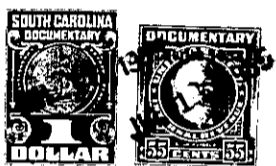

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 26, Plat of North Acres, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "EE", pages 12 and 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Neal Circle, joint front corner Lots 26 and 27, and running thence S. 10-50 E. 100 feet to an iron pin, joint rear corner Lots 26, 27, 36 and 37; thence S. 79-10 W. 80 feet to an iron pin, joint rear corner Lots 25 and 26; thence N. 10-50 W. 100 feet to an iron pin, joint front corner Lots 25 and 26 on the Southerly side of Neal Circle; thence along the Southerly side of Neal Circle, N. 79-10 E. 80 feet to an iron pin, the point of beginning.
