Know All Men by These Presents:

That we, Richard Furman Watson, Jr. and Evelyn Peyton Watson, individually and as Trustee for Richard F. Watson, III and Bernard Peyton Watson, in the State aforesaid, in consideration of the sum of Fifteen Hundred and No/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Airport Realty Co., its successors and assigns, forever:

ALL that lot of land situate on the West side of S. C. Highway No. 291 (By-pass) running from the Laurens Road to the Greenville-Spartanburg Super Highway in the City of Greenville, in Greenville County, S. C. and having according to a survey made by Dalton & Neves, Engineers, June, 1955, the following metes and bounds to wit:

BEGINNING at a point in the West side of S. C. Highway No. 291 (By-pass) said point being 1129.6 feet South from the Southwest corner of the intersection of S. C. Highway No. 291 (By-pass) and Tower Drive, and running thence N. 68-0 W. 190 feet more or less to a point in line of property now or formerly belonging to E. M. Sweat; thence with the joint line of said property S. 26-33 E. 237 feet more or less to an iron pin on the west side of S. C. Highway No. 291 (By-Pass) thence along the west side of said Highway N. 22-0 E. 157.1 feet to the beginning point.

This is a portion of that property conveyed to the Grantors by deed of Richard Furman Watson, recorded in the R.E.C. Office for Greenville County, S. C. in Deed Book 498, page 75, and this deed is executed by the Grantor Evelyn Peyton Watson, as Trustee for Richard F. Watson, III and Bernard Peyton Watson pursuant to the power and authority conferred on her as Trustee by the terms of the above mentioned deed.
