Goldsmith in the State aforesaid, in consideration of the sum of One & 00/100--(\$1.00)-and the partial partition of property----DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said EVA McDONALD TIMMONS AND WALTER W. GOLDSMITH, THEIR heirs and assigns;

ALL that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being situate in or near the corporate limits of the City of Greenville and being known and designated as Lots No. 59A, 59 and 60A of Block "A" of a subdivision known as Airport Villiage Farms, and shown on plat thereof, recorded in the Book of Plats S at Page 161 in the R. M. C. Office for Greenville County, South Carolina, and being more particularly described according to a recent survey by Madison H. Woodward as follows: BEGINNING at an iron pin on Rickenbaker Road at joint front corners of Lots No. 59A and 58 and running thence along the line of said Lot No. 58, S. 74-30 E. 200 feet to iron pin; thence N. 15-30 E. 150 feet to iron pin at rear corner of Lots No. 60A and 60; thence N. 74-30 W. 200 feet to iron pin on Rickenbaker Road; thence withthe said Rickenbaker Road, S. 15-30 W. 150 feet to iron pin at point of beginning. ALSO that portion of Lots No. 71A, 71, 70A, 70, 69, 69A, 68A, 68, 67A, 67, 66A, 66, 64, 64A and 64B, which are not included in the deed of grantors to Greenville Airport Commission by deed recorded in the R. M. C. Office for Greenville County in Book of Deeds #33 at Page 294; said remainder having the following metes and bounds, to-wit: BEGINNING at an iron pin on Rickenbaker Road at the joint corners of Lots No. 50A and 71A and running thence with Rickenbaker Road, N. 15-30 E. 850 feet to the line of Lot No.6 4A; thence N. 88-40 W. 190.50 feet, more or less, to line of property sold to Greenville Airport Commission; thence with line of property sold to Greenville Airport Commission, S. 1-13 W. 700 feet, more or less, to a point in line of Lot No. 71A and 50A; thence along the joint lines of 71A and 50 A, S. 74-30 E. 200 feet to point of beginning.
