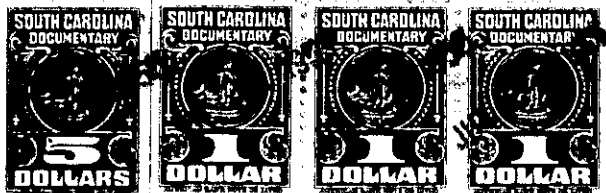
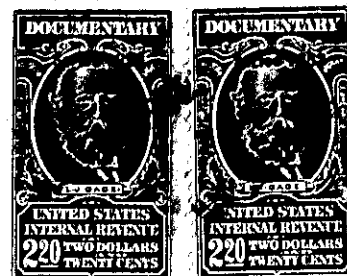

County, State of South Carolina, in the Town of Simpsonville, on Cox Street, and
being Lot Number Thirty One (No. 31) of a plat of land called "Hillcrest",
and described as follows:

BEGINNING at a point on Cox Street and running thence with said
Street, N. 75 E. 60 feet to the corner of Lot No. 30; thence along line
of this lot, S. 15-15 E. 141.8 feet to a stake; thence S. 75-30 W. 60
feet; thence N. 15-15 W. 141.2 feet to the beginning corner.

ALSO: All that other piece, parcel or lot of land in said Township,
County and State, in the Town of Simpsonville, on Cox Street, and being
Lot Number Thirty Three (No. 33) of a plat of land called "Hillcrest",
and described as follows:

BEGINNING at a point on Cox Street, and running thence with said
Street, N. 75 E. 60 feet to a stake; thence S. 15-15 E. 140 1/2 feet to a
stake; thence S. 75-30 W. 60 feet to a stake; thence N. 15-15 W. 140 feet
to the beginning corner.

ALSO: All that other piece, parcel or lot of land in said Township,
County and State, in the Town of Simpsonville, on Cox Street, and being
Lot Number Thirty Two (No. 32) of a plat called "Hillcrest", and describ-
ed as follows:

BEGINNING at a point on Cox Street, and running thence with said
Street, N. 75 E. 60 feet to a stake, corner of Lot No. 31; thence along
line of Lot No. 31, S. 15-15 E. 141.2 feet to a stake; thence S. 75-30 W.
60 feet to a stake; thence N. 15-15 W. 140.6 feet to the beginning corner.
