BEGINNING at an iron pin at joint corner of Lots Nos. 5 and 6 on Circle Drive, and running thence with Circle Drive, N. 7-20 E. 75 feet to iron pin; thence N. 82-40 W. 235.8 feet to an iron pin; thence S. 7-20 W. 75 feet to an iron pin; thence N. 82-40 W. 235.8 feet to the point of beginning. ALSO, an easement 6 feet in width extending along the Northern line of Lots Nos. 6 and 7 adjacent to the Southern line of Lot No. 5. This strip of land is to be used in conjunction with a 6-foot strip of land lying along the Southern line of Lot No. 5 as a roadway so as to furnish a means of ingress and egress from Circle Drive to the owners of Lots Nos. 5, 6 and 7, their Heirs and Assigns.
