to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JOHN W. BELL and LAURA E. BELL, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 78 of a subdivision known as Section "B", of Englewood Estates, as shown by a Plat thereof, dated November, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 11.

BEGINNING at an iron pin on Buffalo Drive at joint front corners of Lots No. 77 and 78 and running thence along the line of said Lot No. 78, S. 87-30 E. 442.1 feet to iron pin; thence S. 3-02 W. 60 feet to iron pin on Sioux Drive; thence running with the said Sioux Drive N. 87-30 W. 416.3 feet to iron pin at curve; thence in a northeasterly direction 34.6 feet to iron pin on Buffalo Drive; thence running with the said Buffalo Drive, N. 2-30 E. 35 feet to iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than fifty (50) feet to the street.
3. No temporary house is to be erected on said lot.

GRANTEE to pay taxes for the year 1955.

THIS deed is subject to any right-of-ways now existing.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
