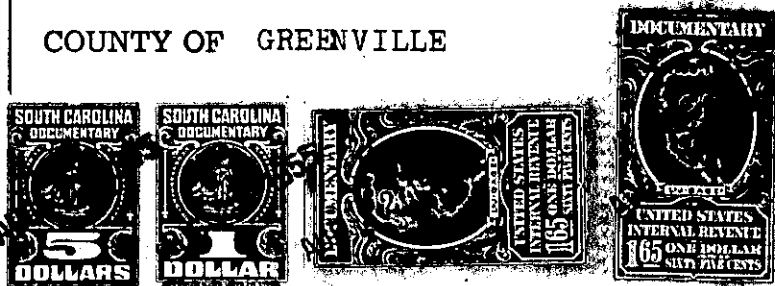

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
 these presents do grant, bargain, sell and release unto the said Joe Weisner, his heirs  
 and assigns forever:

those  
 all ~~that~~ pieces parcels or lots of land in Gantt Township, Greenville

County, State of South Carolina, situate, lying and being on both sides of  
 Morris Court and being known and designated as Lots Nos. 9-D, 9-E, and  
 9-F of a re-subdivision of Lots Nos. 7, 8, 9 and 30 of Monteith Heights  
 as shown on a Plat of Survey by Pickell & Pickell, Engineers, dated  
 March 11, 1948, and having according to said Plat the following metes  
 and bounds, to wit:

Lot 9-D: BEGINNING at an iron pin on the South side of Morris Court, at  
 the joint front corner of Lots Nos. 9-C and 9-D running thence with the  
 joint line of said lots, S. 4-10 E. 100.2 feet to an iron pin at the  
 joint rear corner of said lots; thence N. 84-00 E. 100 feet to an iron  
 pin at the joint rear corner of Lots Nos. 9-D and 9-E; thence along the  
 joint line of Lots Nos. 9-D and 9-E, N. 8-54 W. 103.4 feet to an iron  
 pin at the joint front corner of said lots on the South side of Morris  
 Court; thence along the South side of Morris Court, S. 81-48 W. 80 feet  
 to the beginning corner.

Lot 9-E: BEGINNING at an iron pin on the South side of Morris Court at  
 the joint front corner of Lots Nos. 9-D and 9-E, and running thence with  
 the line of Lot No. 9-D S. 8-54 E. 103.4 feet to an iron pin, joint rear  
 corner of said lots; thence N. 84-00 E. 100 feet to an iron pin; thence  
 N. 28-15 W. 114.6 feet to an iron pin on the South side of Morris Court;  
 thence along Morris Court, S. 81-48 W. 61.5 feet to the beginning corner.

Lot 9-F: BEGINNING at an iron pin joint corners of lots 6, 7 and 30  
 and running thence S. 28-15 E. 102.5 feet to a point at new dead end  
 street; thence along North side of said street S. 81-48 W. 97.9 feet  
 to an iron pin; thence N. 25-15 E. 114.55 feet to point of beginning.

Lot 9-D is the same conveyed to H. C. Gibson by Virginia B. Mann by  
 deed dated January 27, 1955, recorded in the R. M. C. Office for Green-  
 ville County in Deed Book 530, page 176. Lot 9-E is the same conveyed
