

H. Roe; thence along said line M. 19½ E. 3.33 chains to the beginning corner and containing 1.35 heres more or less.

Lot #2

BEGINNING at a stake in the center of Tugaloo head and running thence 3. 40½ %. 4.14 chains to a stone in Roe's line; thence along Roe line N. 49½ ... 1.00 chains to a stone; thence N. 40½ ... 1.23 chains to an iron pin on Tugaloo Road; thence along said Road S. 43 ... 1.00 chains to the reginning corner and containing .42 acres more or less.

Lot #3

BEGINING at corner of property now or formerly awared by Gullick and in the Tugalor Road and running thence southeast with Gullick line to property now or formerly owned by Mrs. Elizabeth Roe; thence with her line to the new Tugaloo Road; thence with the new Tugaloo Road to the beginning corner and containing 12 acres more or less.

The above property was conveyed to the grantors in Deed Book 151, at Page 171, and Francis Avery Hightower subsequently conveyed his interest to Avery F. Hightower in Deed Book 295, at Page 141, and Avery F. Hightower died July 1, 1946 and devised his interest to Marie 2. Lightower for life and then to Francis A. Hightower.
