## CHARTER BY THE SECRETARY OF STATE

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is ARMSTRONG FOODS, INC.

THIRD: That the principal place of business is Greenville, South Carolina

FOURTH: That the general nature of the business which it is proposed to do is to prepare, distribute and sell at wholesale and retail food and drink products and to sell and distribute at wholesale and retail other associated and novelty items.

FIFTH: That the amount of the capital stock is Thirty Thousand (\$30,000.00) ----- Dollars payable when issued.

SIXTH: That the number of shares into which the capital stock is divided is Three Thousand (3,000)

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Piedmont

a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
