All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, and now within the corporate limits of the City of Greenville, and being known and designated as Lot No. 6, of a subdivision known as Carver Park as shown on plat thereof as recorded in the R. M. C. office for Greenville County in Plat Book AA, at page 187, and having, according to said plat, the following metes and bounds, to-wit:
