to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said LANIER M. ALLISON AND DEE S. ALLISON, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Northwest side of Nottingham Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 183 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "GG", pages 70 and 71, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Nottingham Road at joint front corner of Lots Nos. 182 and 183, and running thence along the line of Lot 182, N 20-17 W, 191.8 feet to an iron pin; thence N 55-53 E, 41.4 feet to an iron pin; thence N 74-04 E, 35 feet to an iron pin; thence with the line of Lot 184 S 20-17 E, 199.1 feet to an iron pin on the Northwest side of Nottingham Road; thence with the Northwest side of Nottingham Road S 69-43 W, 75 feet to the beginning corner.

This is a portion of that property conveyed to the Grantor and John T. Douglas by deed of The First National Bank of Greenville, S. C., as Substituted Trustee under the will of J. Sproull Marshall, deceased, dated March 1, 1951, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 430, page 155. Subsequently John T. Douglas conveyed his interest in the above lot to the Grantor, L. A. Moseley by deed dated March 30, 1955, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 526, page 59.

This property is conveyed subject to restrictions recorded in Deed Book 492, page 221.

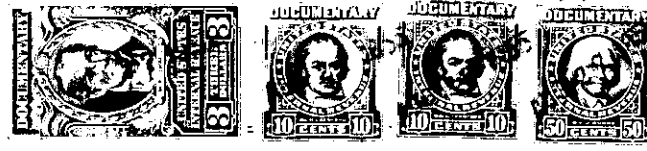
