HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said H. F. Littlefield and Wilma G. Littlefield,

All that certain piece, parcel or tract of land situate in Butler Township, County and State aforesaid, and being known and designated as Tract No. 5 and containing twenty and 20/100 (20.20) acres, more or lcss, according to a sub-division and plat of the Stewart Gresham place made by W. M. Nash, Surveyor, Oct. 24, 1929, and having the following metes and bounds and courses and distances, as shown by said plat, to-wit: Beginning at a stone on the north bank of Feter's Creek; southwest corner of Tract No. l of said subdivision, and running thence along the line of land of Lirs. W. H. Bridwell S.4.23 W.16.30 to a stone in old road; thence running along the line of land of C. F.
