O. B. Ayers and Margaret J. Ayers, their heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the easterly side of Bent Twig Drive, near the City of Greenville, S. C., being shown as Lot No. 18 on the plat of Biltmore as recorded in the REC Office for Greenville County, S. C. in Plat Book "Y", page 147, and having according to said plat the following notes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Bent Twig Drive at a point 262.2 feet north of the northeasterly corner of the intersection of Bent Twig Drive and Two Notch Road, said pin being the joint front corner of Lots Nos. 17 and 18, and running thence along the easterly side of Bent Twig Drive N 14-46 E 75 feet to an iron pin, joint front corner of Lots Nos. 18 and 19; thence along the joint line of said Lots S 75-14 E 150 feet to an iron pin, joint rear corner with Lot No. 35; thence along the joint rear line with said Lot S 14-46 W 75 feet to an iron pin, joint rear corner with Lot No. 17; thence along the joint line with said Lot N 75-14 W 150 feet to the point of beginning.
