S. ULMER, His Heirs And Assigns,

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot No. 80 as shown on plat of Pine Brook Development made by W. N. Willis, Engineer, on March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "2", at Page 148, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Bidwell Street, joint front corner of lots 78 and 80, and running thence along the common line of said lots, S.56-29 W. 150 feet to an iron pin, joint rear corner of lots 53 and 80; thence along the common line of said lots, N.33-31 W. 75 feet to an iron pin; thence along line of lot 82, N.56-29 E. 150 feet to an iron pin on Bidwell Street; thence along Bidwell Street, S.33-31 E. 75 feet to an iron pin, point of the beginning.

This conveyance is made subject to the Restrictive and Protective Covenants applicable to Pine Brook and recorded in the R.M.C. Office for Greenville County, South Carolina, in Book of Deeds 443, at Page 307, and Book of Deeds 462, at Page 33.

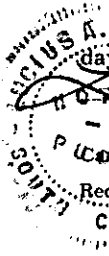
