to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JAMES PERRY AIKEN, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 13, Section I, Lake Forest Subdivision, plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Lake Fairfield Drive, joint front corner Lots 13 and 14, and running thence N. 44-11 W. 281.1 feet to an iron pin, joint rear corner Lots 13 & 14; thence S. 80-21 E. 200 feet to an iron pin; thence S. 49-47 E. 139.4 feet to an iron pin; thence S. 56-14 E. 267.5 feet to an iron pin on the Northwesterly side of Lake Fairfield Drive, joint front corner Lots 12 and 13; thence along the Northwesterly side of Lake Fairfield Drive N. 45-55 E. 95 feet to an iron pin, the point of beginning.
