ALL that piece, parcel or lot of land, situate, lying and being on the Western side of LeGrand Blvd., near the City of Greenville, in the County of Greenville, State of South Carolina, known and designated as Lot #127, as shown on plat entitled "Sherwood Forest" made by Dalton Reeves, August 1951, and recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Pages 30 & 31, and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the Western side of LeGrand Blvd. at the joint front corner of Lots #126 and 127, and running thence along the common line of said two lots S. 88-30 W. 150 ft. to an iron pin on the Eastern line of Lot #125, thence with side line S. 1-30 E. 70 ft. to an iron pin at joint rear corner of Lots #127 & 128, thence with their common line N. 88-30 E. 150 ft. to an iron pin on Western side of LeGrand Blvd., thence along Western side of said Blvd. N 1-30 W. 70 ft. to an iron pin, the point of beginning.

THIS conveyance is made subject to restrictive covenants applicable to "Sherwood Forest" which are of record in the R. M. C. Office for Greenville County, South Carolina in Deed Book 457, at Page 177.

THIS being the same property conveyed to us by DeWitt Edward Phillips and Clara E. Phillips by deed dated September 6, 1955 and recorded in the R. M. C. Office for Greenville County, S.C. in Deed Vol. 533, at Page 477.

THIS Deed is given to correct an error in the prior deed so that Blanche R. Speed will own a 4/6th or 2/3rd interest in the above property and Mary Speed Sherard will own a 2/6th or 1/3rd interest in the property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
