M. W. FORE, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 27 of a subdivision known as Section "C", of Englewood Estates, as shown by a Plat thereof, dated December, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 13.

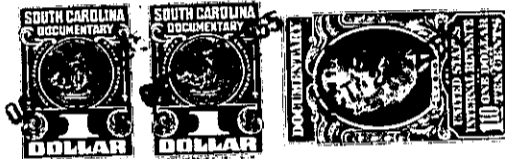
BEGINNING at an iron pin on Shasta Drive at joint front corners of Lots No. 27 and 28 and running thence along the line of said Lot No. 28, N. 2-30 E. 184.9 feet to iron pin; thence along the line of Lot No. 26, S. 56-24 W. 207.7 feet to iron pin on Evelyn Drive; thence running with the said Evelyn Drive, S. 36-20 E. 55.3 feet to iron pin at curve; thence running in a Southeasterly direction 45.1 feet to iron pin on Shasta Drive; thence running with the said Shasta Drive, S 87-30 E. 92.4 feet to iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than Five Thousand (\$5,000.00) Dollars.
2. No house is to be built closer than fifty (50) feet to the street.
3. No temporary house is to be erected on said lot.

THIS deed is subject to any right-of-ways now existing.
