

IN TRUST NEVERTHELESS, for the following uses and purposes, to-wit: To hold, manage, control, improve, mortgage, sell, convey, re-invest and to do those things necessary which said trustee in his discretion deems necessary and after deducting the necessary and proper charges or expenses connected with the management and administration of said trust estate, including repairs, taxes and insurance, said trustee shall apply the proceeds of the corpus of the trust towards the education, maintenance and support of Judith Ann McCorkle, Robert Bisaner McCorkle, Randal Boman McCorkle, Mary Bill McCorkle and Faye Adelle McCorkle with the full power and authority invested in said trustee to use any portion or all of the corpus of said trust, should said trustee deem the same to be necessary, for the above stated purpose and that said trustee is directed to convey said property herein, or the substituted corpus of said trust estate to the said Judith Ann McCorkle, Robert Bisaner McCorkle, Randal Boman McCorkle, Mary Bill McCorkle, and Faye Adelle McCorkle, when the youngest of the named children obtains the age of 21 years, provided however, that in the event that any one of the said children should decease prior to obtaining the age of 21 or prior to the termination of this trust, then the surviving issues, if any, shall take the deceased child's part and if there be no surviving issue of said deceased child, the remaining children shall share the deceased child's part, if at the time the youngest child above named obtains the age of 21 and there remains a surviving issue of one of the children above named who has predeceased this date, the trustee is to convey to the above named surviving children their share in the corpus of the trust estate and is to continue to hold as trustee the interest of the surviving issue of a predeceased child until such time that the surviving issue of a predeceased child obtains the age of 21, at which time the trustee is to convey in equal shares the remainder to the surviving issues of a predeceased child or to their heirs and assigns forever. In the event all of the above named children shall decease without issue said trust estate shall be void and the trust estate shall revert to my estate and become a part of my property and the trustee is hereby directed to execute the necessary instruments to that end. In the event the said trustee shall decease prior to the termination of this trust estate as above provided then and in that event I do hereby nominate constitute and appoint myself, Daisy Mae McCorkle and The South Carolina National Bank of Greenville, S.C. as co-trustees for the above named beneficiaries and the said co-trustees are to have the same power and authority as above delegated to the named trustee and are to carry out the termination plan as above stated. It is further provided that in the event I, Daisy Mae McCorkle, should not be living on the happening of such above named event, or if for any reason, I should not qualify then the South Carolina National Bank is to serve as sole trustee in carrying out the terms, conditions and terminations as above set forth. Compensation to trustee or trustees shall be in accordance with the laws of the State of South Carolina.
