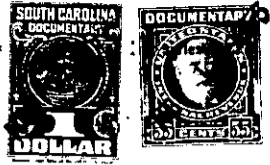

Know All Men by These Presents:

That I, Ralph D. Belue, in consideration of the sum of Four Hundred (\$400.00) in the State aforesaid, DOLLARS,

William C. Belue to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William C. Belue and his heirs and assigns forever:

All of that parcel or lot of land in Oneal Township of Greenville County, South Carolina, situated on the South side of the CC Camp Road, near State Highway No. 14 and East therefrom and about 1 1/2 miles North from Greer, known and designated as Lot No. 8 on a plat of property made for B.W. Waters by H.S. Brockman, Surveyor, dated June 18, 1949, and having the following courses and distances:

BEGINNING on an iron pin on the South side of said CC Camp Road, corner with lands formerly owned by L.E. Hodge, and runs thence with that line S. 10.22 E. 147 feet to an iron pin; thence continuing with the Hodge line S. 10.02 E. 53 feet to an iron pin; thence N. 87.26 W. 100 feet to a stake; thence N. 6.52 W. 237.9 feet to a stake on the South side of the CC Camp Road; thence therewith S. 64.16 E. 100 feet to the beginning corner, and being all of that lot of land conveyed to me, the grantor by the grantee herein by deed dated March 28, 1955, recorded in the R.M.C. Office for Greenville County in Deed Book 521, at page 461.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
