to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said MARION T. WHITE AND MARTHA L. WHITE, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being on the North side of Sunny Lane, in Grove Township, in Greenville County, State of South Carolina, lying West of the Greenville-Piedmont Road (known as U. S. Highway 29), and being shown as Lot No. 21-A, on plat of property of R. E. Dalton, made by Dalton & Neves, Engineers, November 1947, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "S", at Page 15, and having, according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the North side of Sunny Lane at joint front corner of Lots 21-A and 22 and running thence along the line of Lot No. 22, N 4-14 E, 516 feet to a point in center of branch; thence up the branch following the center line thereof (the traverse line being N 85-29 E, 191.9 feet and S 80-32 E, 9.7 feet) to a point in center of said branch; thence along the line of Lot 21, S 4-10 W, 547.7 feet to an iron pin on the North side of Sunny Lane; thence along the North side of Sunny Lane, N 70-42 W, 15 feet to an iron pin; thence continuing with the North side of Sunny Lane, N 85-46 W, 185 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

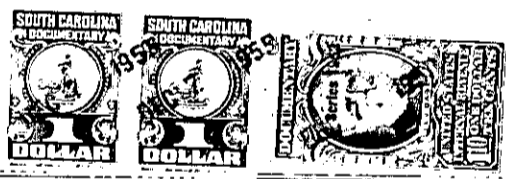
