Wiggins, Sr., and Ruth G. Wiggins, their heirs and assigns: All that lot of land on the north side of Lady Marion Lane, in the City of Green-ville, in Greenville County, S. C., being shown as Lot No. 119 on mlat of therwood Forest, made by Balton & Neves, Engineers, August, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in "lat Book "GG" at pages 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Lady Marien Tane at joint front corner of Lots 118 and 119, and running thence with the line of Lot 118, N. 27-14 W., 155 feet to an iron pin; thence N. 62-46 W., 75 feet to an iron pin: thence with the line of Lot 120, S. 27-14 E., 155 feet to an iron pin on the north side of Lady Marion Lane; thence along the north side of Lady Marion Lane, S. 62-46 W., 75 feet to the beginning corner, and being the same lot of land as conveyed to me by John T.
