

All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as Lot No. 7, on plat of Donald E. Baltz, recorded in plat book BB page 175 of the R. M. C. Office for Greenville County, S. C., and having according to a recent survey made December 1955 by R. W. Dalton, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the northeastern side of Myron Lane, the front joint corner of Lots Nos. 6 and 7; thence with the joint line of said lots No. 30-01 E. 111 feet to an iron pin; thence N. 75-43 W. 114.4 feet to an iron pin on the southeastern side of Edgefield Road; thence with the southeastern side of said Edgefield Road S. 30-01 W. 60 feet to an iron pin; thence with the curve of said road as it intersects with Myron Lane, S. 14-59 E. 28.3 feet to an iron pin on the northeastern side of Myron Lane; thence with the northeastern side of said Myron Lane. S. 59-59 E. 90 feet to the beginning northeastern side of said Myron Lane, S. 59-59 E. 90 feet to the beginning corner.
