Simmons in the State aforesaid, in consideration of the sum of Twenty-Five Thousand and No/100ths (\$25,000.00) - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Julius Weinfeld, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, known and designated as Lot No. 107 on a plat of property of Central Development Corporation recorded in the R. M. C. Office for Greenville County on October 23, 1951 in Plat Book Y at pages 148 and 149, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Stephen Lane at the joint front corner of Lots Nos. 106 and 107, and running thence along the line of Lot No. 106 S. 31-29 W. 213.2 feet to an iron pin; thence along the line of Lot No. 110 S. 29-07 E. 34.2 feet to an iron pin; thence along the line of Lot No. 108 N. 51-47 E. 221.2 feet to an iron pin on the Southwest side of Stephen Lane; thence along Stephen Lane N. 38-12 W. 55 feet to an iron pin; thence still along Stephen Lane N. 54-52 W. 55 feet to the beginning corner.

This property is conveyed subject to the restrictive covenants recorded in the R. M. C. Office for Greenville County in Deed Book 444 at page 429 and being the same property conveyed to the grantors herein by deed recorded in Deed Book 472 at page 56.
