Office in Plat Book "U" at Page 139, the following metes and bounds to-wit: BEGINNING at an Iron pin on the South side of Wedgewood Avenue, 100 feet S. 51-19 W. from the joint front corner of Lots 12 and 14, and which pin is 600 feet more or less from the Northern edge of Rutherford Road; thence S. 16-03 £. 218.7 feet to an Iron pin; thence N. 52-58 E. 78.9 feet to an iron pin; thence N. 06-46 E. 50 feet to an iron pin, corner of lot heretofore sold to Allen; thence along Allen line, N. 11-51 . 241.6 feet to an iron pin on South side of Wedgewood Avenue; thence along South side of said Avenue, S. 53-20 W., 50 feet to an iron pin at the joint front corner of Lots 12 and 14; thence continuing along said Avenue 5. 51-19 W. 100 feet to point of beginning. This property is conveyed subject to an easement granted the City of Greenville for a water line crossing the property as shown on the above recorded plat. Being the identical property conveyed to the grantor by deed of W. Rufus Ellis, dated November 26, 1954, recorded in Deed Book 513 at Page 119.
