All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being a portion of the Property of E. J. Jaskwhich, plat of which is recorded in the R.L.C. Office for Greenville County, South Carolina, in Plat Book "DD", page 179, and having the following notes and bounds, to-wit:

BEGINNING at an iron pin at the corner with property of the grantee and running thence S. 40-46 E. 539 feet to a point in Brushy Creek; thence with Brushy Creek as the property line, the traverse line being N. 21-47 E. 23.6 feet to a point; thence through the property of the grantor N. 34-33 W. 543.7 feet to a point in the corner line of the property of the grantor and the grantee; thence S. 30-14 W. 60.6 feet to an iron pin, the point of beginning.
