

All those pieces, parcels or lots of land situate, lying and being in Gantt Township, Greenville County, South Carolina. being known and designated as Lots Nos. 1, 2 and 3 on plat of property of Fairfield Acres recorded in the RMC office for Greenville County in plat book FF at page 109, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Fairfield Road, joint front corner of Lots Nos. 1 and 2, and running thence with Fairfield Road, S. 23-11 W., 127.7 feet to and iron pin at the northeast intersection of Fairfield Road with Lanford Drive; thence with Lanford Drive, S. 57-01 E., 12 feet to bend; thence S. 65-42 E., 50 feet to bend; thence S. 79-42 E., 50 feet to bend; thence still with Lanford Drive, S. 86-42 E., 75 feet to an iron pin at the front corner of Lot No. 4; thence with the line of Lot No. 4, N. 2-50 E., 150 feet to an iron pin on a two (2) foot reserved strip; thence N. 86-42 W., 38.7 feet; thence N. 3-34 E., 295 feet, more or less to an iron pin on the easterly side of Fairfield Road; thence with the easterly side of Fairfield Road in a southwesterly direction, 350 feet, more or less, to the point of beginning.
