

Haynsworth, Trustee, as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "L", Page 177 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Cedar Lane Road at joint front corner of Lots Nos. 5 and 6, said pin also being 554:5 feet in a northwesterly direction from the point where the northeast side of Cedar Lane Road intersects with the northwest side of Worth Street, and running thence with the line of Lot No. 5, N. 34-00 E. 300 feet to an iron pin; thence along the rear line of Lot No. 15, N. 58-30 W. 100 feet to an iron pin; thence with the line of Lot No. 7, S. 34-00 W. 300 feet to an iron pin on the northeast side of Cedar Lane Road; thence with the northeast side of Cedar Lane Road, S. 58-30 E. 100 feet to the beginning corner.
