All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, Butler Township, near the City of Greenville, being shown as Lot 25 on a plat of Lake Forest Heights made by Piedmont Engineering Service, November, 1955, recorded in Plat Book GG at Page 153, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Scotland Circle at the joint front corner of Lots 25 and 26 and running thence with the line of Lot 26 N. 23-18 W. 213 feet to an iron pin; thence S. 37-38 W. 156.2 feet to an iron pin at rear corner of Lot 24; thence with the line of Lot 24 S. 43-15 E. 172.2 feet to an iron pin on Scotland Circle; thence with the northwestern side of Scotland Circle N. 51-48 E. 100 feet to point of beginning.
