


RODGERS, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, lying and being situate on the South side of Pleasant Ridge Avenue, being known and designated as Lot 147, Pleasant Valley, according to plat of said subdivision prepared by Dalton & Neves, Engineers, in April, 1946, as recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "P", page 93, and having, according to said plat, the following metes and bounds, to vit:
