UNGER in the State aforesaid, in consideration of the sum of TWO THOUSAND FIVE HUNDRED TEN & 90/100 DOLLARS, and assumption of mortgage described below; to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HENRY BRUCE SMITH, his heirs and assigns:

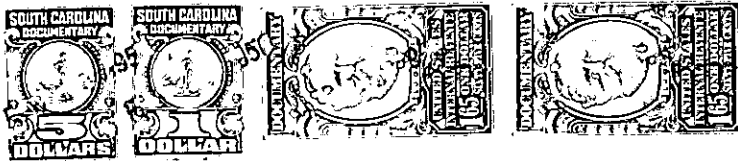
All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 148, Paramount Park, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "7", page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Crosby Circle, joint front corner Lots 148 and 149, and running thence S. 13-24 W. 189.9 feet to an iron pin; thence S. 50-30 E. 54.2 feet to an iron pin; thence N. 64-00 E. 79.5 feet to an iron pin, joint rear corner Lots 147 and 148; thence N. 3-24 W. 179.3 feet to an iron pin on the Southerly side of Crosby Circle, joint front corner Lots 147 and 148; thence around the curve of Crosby Circle, the chord of which is N. 85-0 W. 58.7 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co. on which there is a balance due of \$7,389.10; said mortgage being recorded in Mortgages Volume 223, page 185.
