to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. E. McKinney, his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, County of Greenville, State of South Carolina, near the City of Greenville, North of Rutherford Road, at the joint corner of Pine Street and Scott Street, being the Western portion of Lot No. 8 as shown on a plat of E. E. Watson Property, prepared by G. A. Ellis, July 1945, recorded in the R. M. C. Office for Greenville County in Plat Book "U" at page 181 and having according thereto the following metes and bounds:

BEGINNING on the East side of Pine Street at the intersection with Scott Street, and running thence with the Eastern side of Pine Street S. 22-08 E. 51 feet to an iron pin; thence with the line of Lot No. 7 N. 70 E. 112 feet to a point; thence with the Watson line N. 22-08 W. 51 feet more or less to an iron pin; thence with the South side of Scott Street S. 69-37 W. 112 feet to the point of beginning. This being the same property conveyed to the late Grace E. Phillips by deed recorded in Deed Book 299 at page 108. This deed is executed and delivered pursuant to the powers granted the Executor herein by Item XVII of the Will of Grace E. Phillips filed in Apt. 638, File 17, Probate Court for Greenville County on July 20, 1955.
